I certify that I am physically fit for this activity, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems, which preclude my participation in this activity. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the event holders, sponsors, and organizers of the activity in which I may participate, including any time I am at Fauna Haven Animal Sanctuary, whether visiting or volunteering for them in any way, and that it will govern my actions and responsibilities at said activity. I acknowledge that this activity may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, monitors, and/or producers of the activity. These risks are not only inherent to participants, but are also present for volunteers. I also acknowledge that working with or around animals has inherent risks.

(C) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph, as well as any animals at **Fauna Haven Animal Sanctuary** at any given time from any and all liabilities or claims made as a result of interactions of any kind with animals connected in any way with **Fauna Haven/Fauna Haven Animal Sanctuary**. I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity.
